TDV Board Interview with Clare Early (answers are summarized and not exact quotes)

Clare Logged on approximately 1830 hours.

1. What drew you to Therapy Dogs of Vermont initially and what has your experience been with TDV?(asked By Evan)

A Vet Tech recommended TDV and through Deb, Certified as a team just prior to the pandemic. Claire winters in North Carolina where she advised she was able to do some visits.

As an educator she thought TDV was a great way to getting back into working with kids.

2. What have you enjoyed about being part of TDV and is there anything you've found challenging (wish had been different)? OR What do you see as TDV's greatest strengths and where do you hope TDV grows?((Asked By Valerie)

Clare stated that the monthly woof with visit opportunities has been a great strength versus the huge list on the website. Moving forward, its rebuilding after the pandemic,

to get people interested and volunteer their time beyond just visiting, i.e certification team, etc.

More opportunities for handlers to meet one another.

3. What interests you in being on the Board of TDV and what do you think you personally could bring to the Board? OR What interests you in being on the Board and how do you think you can make a difference in TDV by being on the Board (Asked by Craig)

Clare was an educator for forty years, she taught middle school for thirty and then consulted. During her middle school years she taught math and did not like how the current method of teaching, she became involved with a program called "teachers development group". She has always been interested in how to make math more interesting and engaging, which she discovered it should be taught like science is taught. Believes that kids should make up their own ideas and realizing the rules were made up by someone else, and there may be other rules that work better.

Looking for better ways to accomplish something that may be more mundane, is one of her strengths.
